### **Responsibilities and Duties**

- Conduct monthly fund manager meetings and *ad hoc* property tours.
- Convey information verbally and through written notes and reports after property tour reviews and fund manager monthly update meetings.
- Evaluate real assets investment strategies, fund manager skill, and real assets market trends using both quantitative frameworks and qualitative analysis.
- Analyze underwriting proposals, financial statements & business models for real asset investments.
- Collaborate with PRIM's Real Estate and Timberland team in supporting real asset research initiatives by providing thorough analysis, clear presentations and necessary documentation of relevant information.
- Maintain an awareness of economic conditions and capital markets to form and justify investment recommendations.

### **Minimum Qualifications**

- Graduate degree in economics, finance, accounting or business preferred.
- 1-3 years of prior work experience in investment management preferred.
- Intellectual curiosity regarding real assets investment management and fundamental research.
- Competent practitioner of econometrics and quantitative finance techniques.
- Knowledge of multi-asset strategies, modern portfolio theories, and factor-based investing.
- Programming skills in SQL and/or statistical analysis in VBA, MatLab, or R.
- Ability to comprehend, synthesize, evaluate and clearly communicate complex financial concepts and solutions.
- Ability to work both independently and as part of a team.
- Ability to interact effectively with various stakeholders in and out of the organization.
- Ability to travel up to 20% of the time
