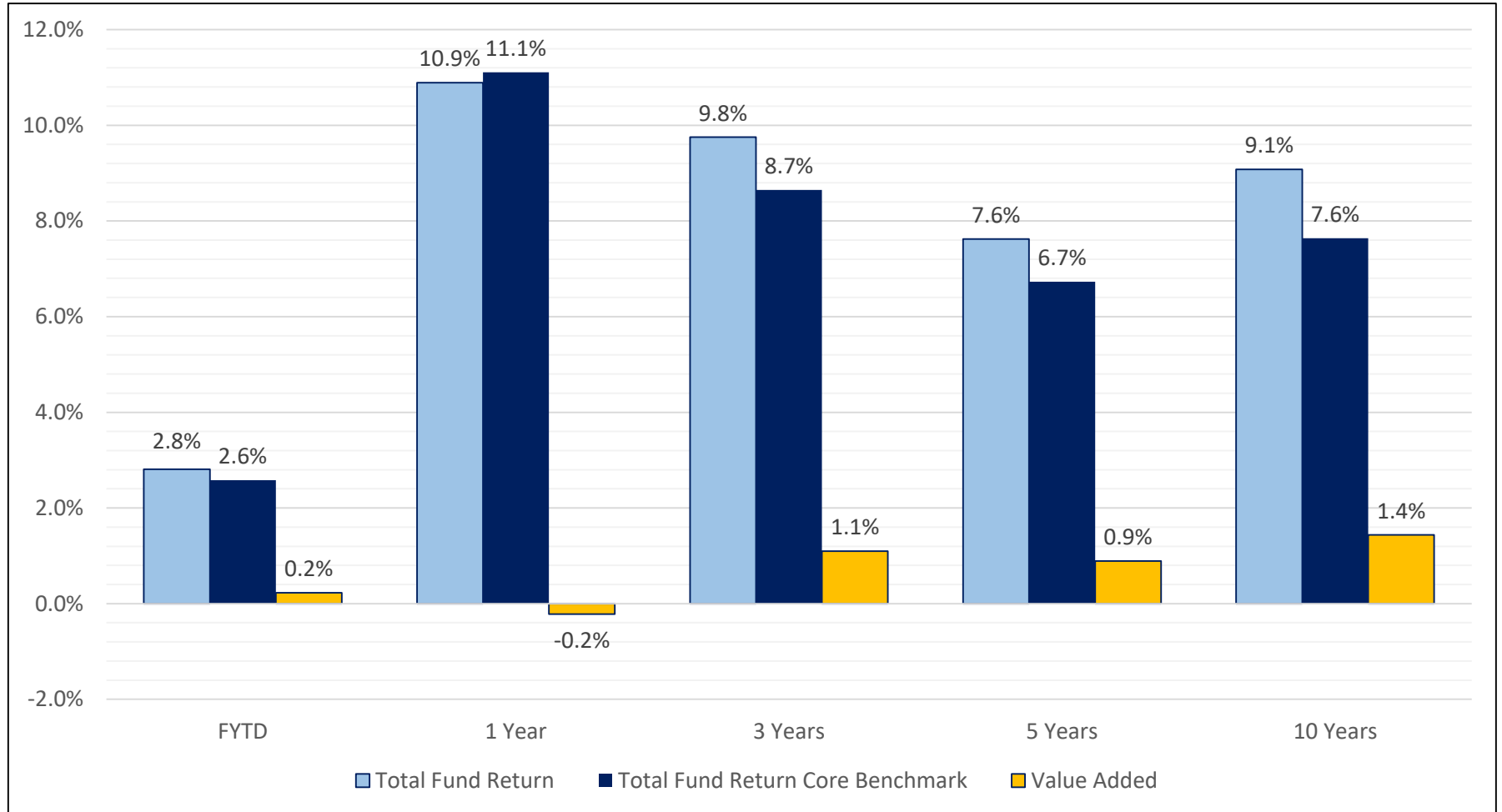


Total PRIT Fund Performance (\$76.9 Billion in Assets)

Gross of Fees as of October 31, 2019



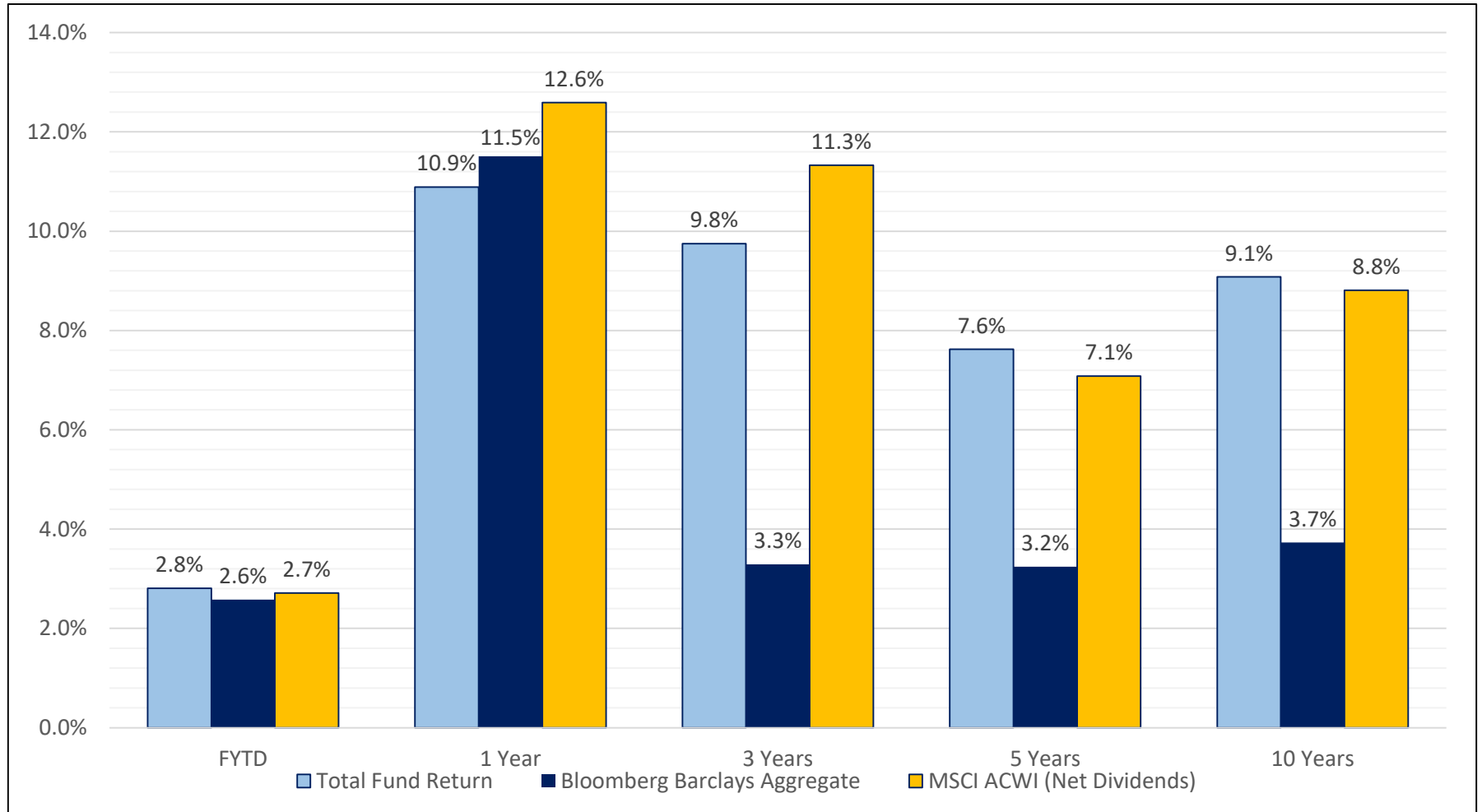

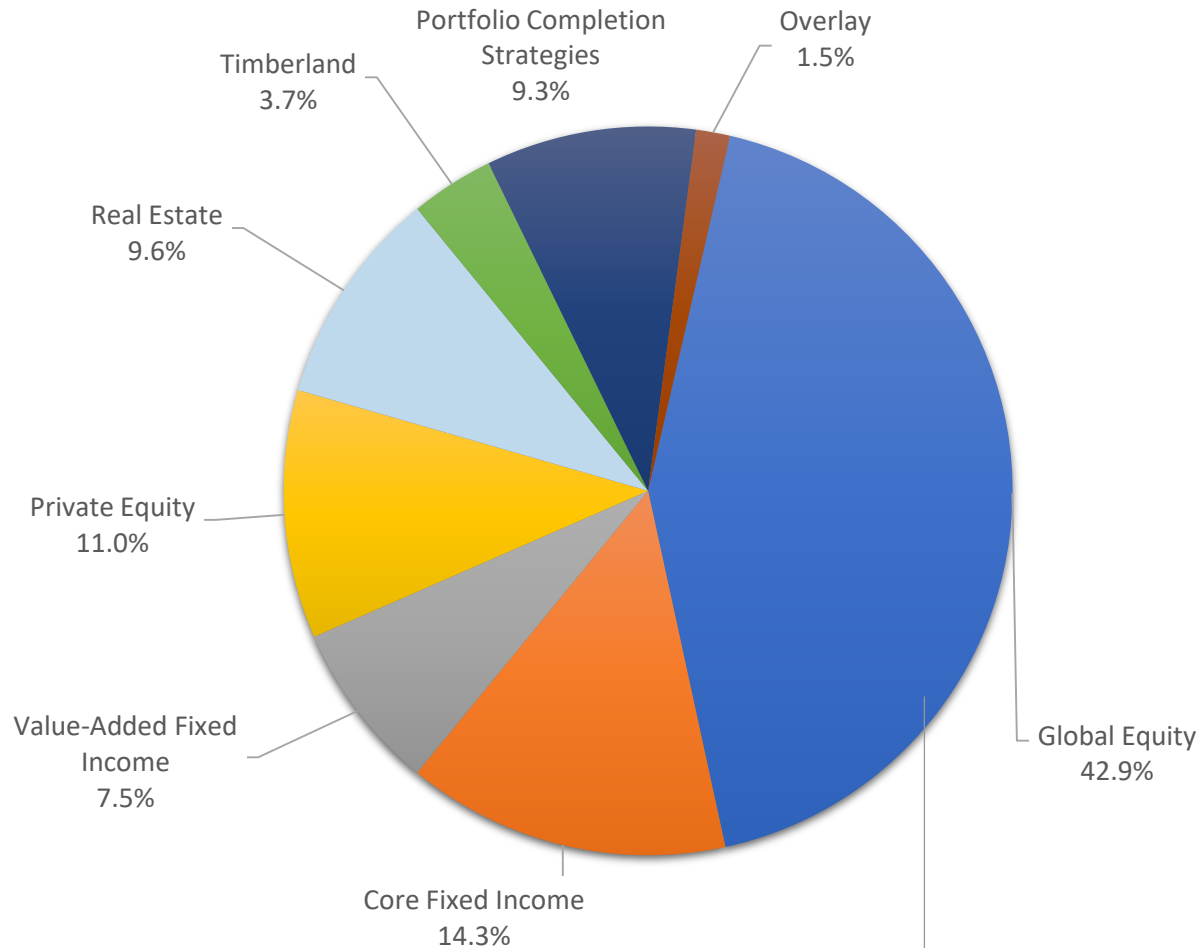
