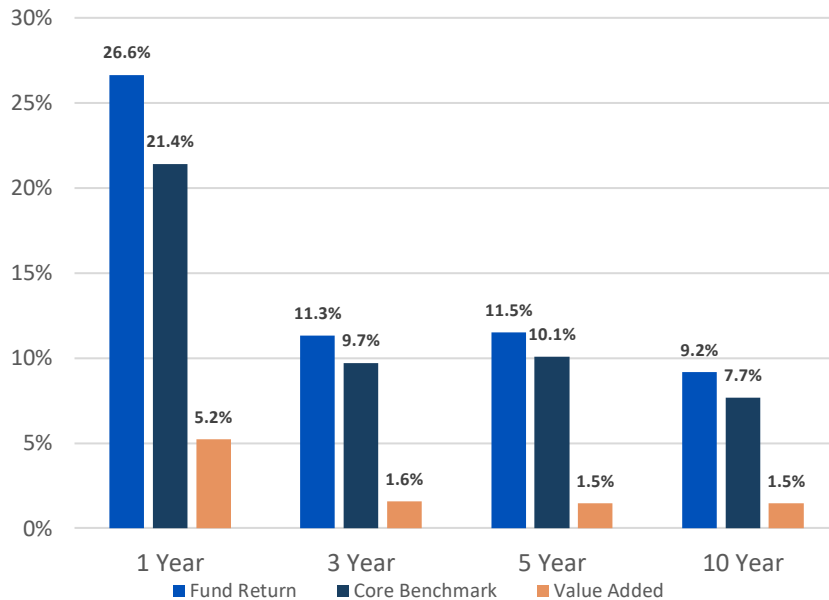
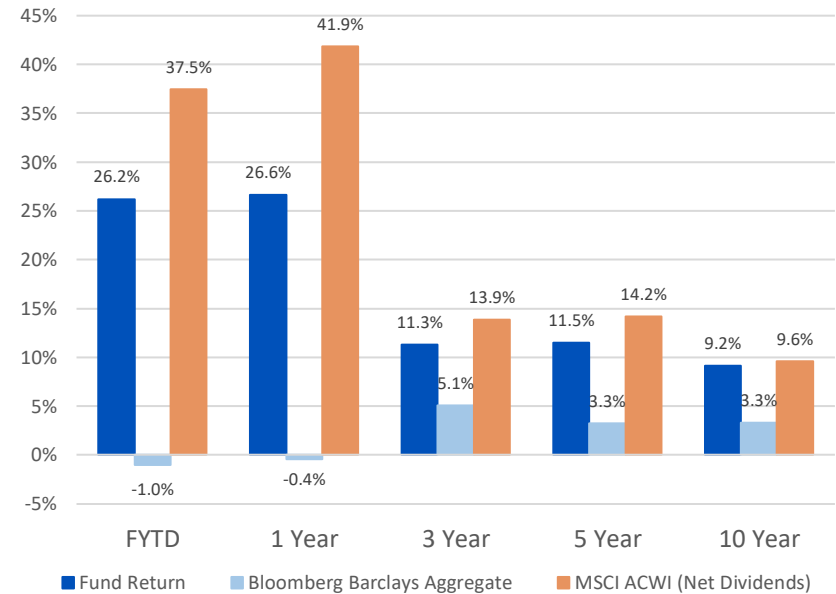


### PRIT Fund Total Returns (Annualized, Gross of Fees)

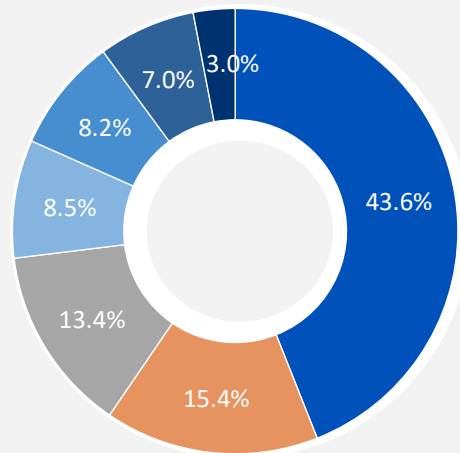


### PRIT Fund Vs Stocks and Bonds (Gross of Fees)
